**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

## WAIT LIST FOR WITHDRAWN ENTRIES

After the closing date, BSCA is offering a Wait List to fill openings created by withdrawn entries after closing. A maximum of 20 dogs will be placed on the wait list. All entries including wait listed entries must be received by the Trial Secretary prior to Wednesday April 10, 2024 5:00 p.m. (MT). Any entries withdrawn prior to 5:00 PM, April 30, 2024, will be replaced by a wait list entry, a full refund will be given to withdrawn entries when wait listed entries are available to replace the pulled entry. Any wait list entry that does not move off the wait list into the trial by 5:00 PM, April 30, 2024 will receive a full refund.

## OBSTACLES

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. Ring measurement 100' x 120'. The trial will be held indoors on the sport turf.

## COURSE FAMILIARIZATION & TIMING

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## AWARDS

Placement rosettes will be awarded for the first through fourth place in each height division of each class for Standard Agility Classes, Jumpers with Weaves classes, FAST classes and T2B classes (1<sup>st</sup> only).

First Place	Blue Rosette
Second Place	Red Rosette
Third Place	Yellow Rosette
Fourth Place	White Rosette

A green qualifying ribbon will be given to all qualifying dogs.

Dogs must receive a qualifying score to receive placement awards.

### Agility High Scoring Awards

**HIT Regular classes:** All Belgian Sheepdogs competing in the Regular Standard agility classes, including all jump heights, shall be eligible for Agility High in Trial award. The High in Trial award shall be based on qualifying scores from the Regular Standard agility classes. A dog must have a Regular Standard Class qualifying score and have a time under Regular Standard course time to be eligible for the Agility High In Trial Award. Agility High in Trial will be awarded based on the following order of consideration.

1. dog/handler team(s) with a Standard score of 100 in the Master/Excellent class
2. dog/handler team(s) with a Standard score of 100 in the Open class
3. dog/handler team(s) with a Standard score of less than 100 in the Open class
4. dog/handler team(s) with a Standard score of 100 in the Novice class
5. dog/handler team(s) with a Standard score of less than 100 in the Novice class

In the event more than one dog/handler teams qualify for the High in Trial award, High in Trial will be determined based on the most seconds under Regular Standard course time. Seconds under Regular Standard course time is based on the Regular Standard course time minus the dog's time. If multiple dog/handler teams tie for the most seconds under Regular Standard course time, then a run-off will determine the High in Trial award. The course for the run-off is at the agility judge's discretion.

**HIT Preferred classes:** Same as HIT Regular Classes except substitute Preferred for Regular.

**High Combined Regular Classes:** All Belgian Sheepdogs competing in both a Regular Standard and Regular Jumpers agility classes, including all jump heights, shall be eligible for the High Combined award. The High Combined award shall be based on qualifying scores from the Regular Standard and Regular Jumpers agility classes. A dog must have Regular Standard and Regular Jumpers qualifying scores to be eligible for the High Combined award. High Combined will be awarded to the dog/handler team with the most points based on the points shown below.

#### High Combined Points

30 points - Master/Excellent qualifying score

20 points - Open qualifying score

10 points - Novice qualifying score

Should multiple dog/handler teams have an equal number of High Combined Points, High Combined will be determined based on the most combined seconds under course time for both Regular Standard and Regular Jumpers classes.

Seconds under course time is calculated based on the course time minus the dog's time for both classes. If multiple dog/handler teams have the most combined seconds under course time, then a run-off will determine High Combined. The course for the run-off is at the agility judge's discretion.

**High Combined Preferred classes:** Same as HC Regular Classes except substitute Preferred for Regular.

## Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day. A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

## Entering For Exhibition Only (FEO)

FEO is only allowed in the Time 2 Beat classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring  
Toys must be non-audible  
Toys may not leave the handler's hand  
Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

## Fix and Go On (FNG)

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

## HEIGHT DIVISIONS

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. If a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

## Are You Entered In The Right Height?

REGULAR	PREFERRED	Height at Withers
Handlers may opt to run their dog in a higher height division.	Handlers must run their dog in their proper eligible height.	Owners are responsible for entering their dog in the proper height division.
8"	4"	For dogs 11 inches and under at the withers
12"	8"	For dogs 14 inches and under at the withers

24"	20"	For dogs over 22 inches at the withers. Regular Dogs may not be entered in this height if they are 22 inches and under.
24C"	n/a	Dogs may be entered at this height at their owner's discretion if their measurement is 22 inches and under at the withers. Dogs who measure into the 24" regular jump height division may not enter 24-choice.

## EXHIBITOR INFORMATION

### SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Belgian Sheepdog Club of America and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Belgian Sheepdog Club of America reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Belgian Sheepdog Club of America or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

All regulations governing the use of this facility, and all regulations and decisions of the trial committee at this trial will be strictly enforced, including and not limited to the recorded information of this premium list.

Puppies under 4 months of age are prohibited at AKC Agility Trials.

**This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.**

### ENTRY ELIGIBILITY

This trial is open to Belgian Sheepdogs dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP).

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number (in trials allowing mixed breed entries) must be spayed or neutered in order to compete. Wherever the word “dog” is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog’s physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

### REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.

No refunds for overpayment of \$10.00 or less.

Change of judge, after the distribution of the premium list, if the judging assignment changes, an exhibitor has the right to request a full refund of their entry fees for any class affected. Exhibitors must submit requests in writing to the Trial Secretary a minimum of 30 minutes preceding the start of the event on the first day the exhibitor is entered.

Bitches in season are not permitted to compete in AKC Agility Trials. The Club will issue a refund for the trial entries, less a \$10.00/entered day processing fee.

Chapter 1, Section 9 of the Regulations for Agility Trials, <http://images.akc.org/pdf/rulebooks/REAGIL.pdf>, states, “Females in season must be fully refunded if withdrawn by the Trial Secretary after closing and no later than one half hour prior to the start of the first class of the day of the trial. The club may retain a processing fee and must publish this information in the premium (no fee is paid to the American Kennel Club for females in season who are withdrawn).”



## CATALOGS

National Specialty catalogs will be available in the on-line specialty store for pre-purchase. There "may be" a limited number available at the trial site. Running order sheets will be emailed to all exhibitors with their Final Confirmations. If you wish to use a Running Order at the trial, please print a copy for your own use.

## RINGSIDE

Dogs may arrive any time prior to judging. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. All dogs not needed for further judging will be excused. Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Exhibitors may bring their own chairs.

## PARKING

Exhibitors are governed by any rules or regulations of civil authorities and building and parking regulations. Vehicles parked contrary to regulations will be subject to towing at owner's expense. PLEASE NOTE: A limited number of handicap spaces are available. They will be available on a first-come basis. A valid handicap plate must be on each vehicle using these spaces. THESE SPACES WILL NOT ACCOMMODATE MOTOR HOMES.

RV's: The facility will not allow overnight RV parking. Club officials may require that vehicles or equipment be rearranged to accommodate additional vehicles. Area around vehicles MUST be kept clean at all times. All vehicles will be parked at owner's risk. Under the Sun Dog Training and Belgian Sheepdog Club of America will not be responsible for loss by burglary, fire, or any other cause whatsoever to the vehicle or its contents.

## SITE INFORMATION

Under the Sun will allow unentered dogs, owned by exhibitors. DOGS MUST BE ON LEAD AT ALL TIMES WHEN GOING IN AND OUT OF THE BUILDING OR WHEN WALKING TO AND FROM THE WARM UP RING AREA. DOGS MUST BE CONFINED TO A CRATE EXCEPT WHEN COMPETING OR WITHIN THE WARM UP RING AREA.

Do not allow your dog to relieve itself on the flowers, landscaping or rock areas along the walk ways and building surroundings. The fabric under the rocks will retain the urine smell so do not allow your dogs to relieve themselves on the rock area.

Dog treats that DO NOT crumble will be allowed on the turf area. Please do not drop your treats on the turf.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

## CRATING and SEATING

**Some crating space will be available. A clean mat or tarp is required under ALL kennels and crates. Crating areas will be designated by the Club. No crating will be allowed in front of any doors or blocking halls. Please be courteous and do not take more space than you need. BSCA has the right to make crating area changes to benefit the trial and exhibitor needs.**

Crates may not be left overnight. The Belgian Sheepdog Club of America and Under the Sun Dog Training will not be responsible for any lost or damaged items left at the show site.

No food concessions will be available on site. Many food establishments are nearby. There will be some vendors on site.

**Regulations for Agility Trials: Chapter 1, Section 20:** Move-Up entries will be accepted for dogs that have completed a title after the closing date. Email notification of move up or class change is acceptable, with return receipt verification from the secretary. Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM on the Monday evening preceding the event. Move-up entries for Saturday or Sunday must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order. Move-ups can only be accepted if judging limits are not exceeded.

Entry move-up valid only if the dog was already entered in the Event indicated and only if approved by the Trial Secretary. Dogs moved up will run at the end of the class running order.

**Chapter 1, Section 21. Change of Entry.** In addition to Move-ups as described in Chapter 1, Section 20 entries may also be changed as noted in this section. A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions:

The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to the Novice "B" class.

After the close of entries a dog may be moved down in their class level (i.e., Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the superintendent or trial secretary at least 30 minutes prior to the start of the trial.

If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.
